RESOLUTION TO APPOINT THE MUNICIPALITY OF SHAWVILLE ASPROJECT LEADER FOR THE REQUEST FOR FINANCIAL ASSISTANCEWITHIN THE FRAMEWORK OF SECTION 4 - SUPPORT TO INTERMUNICIPAL COOPERATION (VOLET 4 – SOUTIEN À LA COOPÉRATION INTERMUNICIPALE)

WHEREAS the Government of Quebec, through the Ministry of Municipal Affairs and Housing (MAMH), has established a program to promote intermunicipal cooperation;

WHEREAS this program is available through Component 4 of the Fonds régions et ruralité (FRR), which has a national envelope of \$15 million for the years 2021-2022 and following;

WHEREAS the "cooperation" axis of component 4 aims to help local municipalities offer quality municipal services at reasonable cost by concluding intermunicipal agreements relating to the management of equipment, infrastructure, services or activities, or to study the opportunity;

WHEREAS the financial assistance that can be granted by the MAMH represents a maximum of 80% of eligible expenses, for a maximum amount of \$250,000 for applications including municipalities in the 5th quintile according to the 2018 Economic Vitality Index (IVE);

WHEREAS the fire protection of the territory of the Municipality of Portagedu-Fort is presently provided by the B.GC.P Fire Safety Service (FSS), with backup being provided by the FSS of the municipalities of Shawville and Clarendon through a mutual service agreement;

WHEREAS the municipality of Clarendon offers to serve the municipality of Portage-du-Fort with permanent fire protection through its SSI by entering into a service agreement to cover its territory;

WHEREAS a draft intermunicipal agreement for the provision of fire safety services between the municipalities of Shawville, Clarendon and Portage-du-Fort was tabled for consultation at this municipal council meeting

WHEREAS the municipalities participating in this draft agreement wish to benefit from financial assistance under Component 4 - support for intermunicipal cooperation of the FRR to purchase a fire truck to improve the fire service to its population

WHEREAS the Municipality of Shawville demonstrates its willingness to present the project to the Ministère des Affaires municipales et Habitation du Québec (MAMH).
